

# **Pet Sitter/Client Agreement**

## **Apartment Boarding**

This agreement is between PAWtime Professional Pet Sitting and Dog Walking, Amy Stewart, and any of its agents (hereafter referred to as Pet Sitter) and \_\_\_\_\_ (hereafter referred to as Client).

This agreement applies to pets rightfully owned by Client, on or after the date this agreement is signed, and for locations designated for service.

Pet Sitter agrees to provide services in a reliable, caring and trustworthy manner. In consideration, Client expressly agrees to waive and relinquish all claims against Pet Sitter except those arising out of negligence of the Pet Sitter.

Client must complete a Service Request before the Pet Sitter will perform any services.

Client authorizes Pet Sitter to seek emergency vet care during visits at the expense of the Client. Client must provide Pet Sitter with Veterinary contact information and a Veterinary Release for their pet(s). Client will pay all veterinary care costs. However, Pet Sitter shall be responsible for veterinary costs if the vet care is due to Pet Sitters negligence.

Client must provide proof that all vaccinations are up-to-date for their pet(s). Client is also responsible for disclosing to Pet Sitter of their pet coming in contact with another animal with a contagious illness.

Client also agrees that their pet has flea and tick repellant applied.

Client is required to disclose any previous aggressive behaviors to Pet Sitter.

Client shall provide their pets own food and a leash and collar. Client may also bring their pets own bedding, treats and toys. Pet Sitter shall provide bedding if client does not.

#### Deposits, Cancellations, Reservation Changes & Payments:

Client will be charged a deposit equal to 50% of the dates requested to be reserved. The deposit is due at the time the reservation is made. Payments may be made by PayPal payment or by check. Payments by check must be received within 7 days.

Cancellations of reservations less than 30 days of the reservation start date will be charged an amount equal to 50% of the dates reserved.

Clients returning early must pay for the entire period requested per the service request.

The remaining balance due for the full amount of reservation, per the Service Request, is due at the time the pet(s) is dropped off for boarding. Unforeseen charges must be paid upon pickup of Clients pet(s)-ie: vet expenses, additional days of service, additional food, etc.

Acceptable forms of payment are check, cash or payments from Paypal, who accepts all types of credit cards. Paypal payments must be sent to [pawtime@ymail.com](mailto:pawtime@ymail.com). Payment made through PayPal will also have a 3% service charge added to clients total bill amount. Returned checks must be paid for in cash upon notice from Pet Sitter. Any charges incurred by Pet Sitter from the Pet Sitters bank must also be paid by Client.

#### Additional Considerations:

Client agrees to pickup their pet(s) on the agreed upon date, per the Service Request. If the Client does not pick up their pet by this date, within 7 days the pet(s) become property of Pet Sitter, at which point the Pet Sitter may sell or turn the pet(s) over to the local Animal Control Facility.

Client agrees to notify Pet Sitter of any concerns within 24 hours of picking up their pet(s).

Pet Sitter expressly agrees to waive the right to hold the Client responsible for injuries to the Pet Sitter caused by Clients pet.

Pet Sitter is not responsible for injuries caused by the Clients pet(s) to the Client.

Pet Sitter reserves the right to terminate this agreement at any time if it is determined that pet poses danger to itself, other pets, people or the Pet Sitter.

Client agrees to indemnify and hold PAWtime Professional Pet Sitting and Dog Walking, Amy Stewart (Pet Sitter) and any associated agents harmless, from and against all loss, damages or expense, including attorney's fees, resulting from misrepresentations by Client or Client's agents and any person claiming to be the owner of Clients pet(s) and any person claiming damage or injury by Client's pet(s).

This agreement is valid from the date signed and replaces any prior agreement. Client agrees to Pet Sitter changes to this agreement to be relayed verbally, by mail or email in writing or by website listed at [www.pawtime.net](http://www.pawtime.net) by clicking on Pet Sitter/Client Agreement.
